

**NARRATIVE**

On 8-15-2023 at approximately 1645 hrs Micheal Sawyer, the property owner of 3 Uncas Ave, called the station to report a possible squatter at his abandoned

property. Michael has had several issues in the past with trespassing at that property and has taken many steps to prevent people from entering the house to include boarding up all the windows and posting several "No Trespassing" signs. Michael reported that there was a man wearing a red baseball cap sleeping on the porch of 3 Uncas Ave.

Det. Millerick responded to the property and located Charlie Wilson, wearing a red baseball cap, at the property. Det. Millerick asked what he was doing there and Charlie replied, "taking a nap." Det. Millerick advised him that he was trespassing and pointed out the several signs clearly displayed. He told Charlie that he needed to collect his belongings and move along. Charlie did, and walked around the house out of sight.

Det. Millerick then got another call and as he was leaving he observed Charlie, now lying down behind the house, at a small cabin still located at 3 Uncas Ave. He requested another officer to respond to speak with Charlie. I, Officer Seth Harlow, and Officer Sutherland responded. We located Charlie posted up with his belongs on the porch of the cabin. I asked Charlie if he was told to leave and he admitted he was. At that time based on the fact that the property is posted with several "No Trespassing" signs, the buildings are boarded up to prevent trespassers, Det. Millerick had just advised Charlie that he was trespassing and need to leave and we located Charlie on the property with no intentions of leaving, that he would be placed under arrest for 266/120 - Trespassing. Charlie was handcuffed, rear DL,

and placed in the back of Officer Sutherland's cruiser. Charlie's belongings were collected to be taken to the jail. Officer Sutherland then transported Charlie to the DCHOC without incident.
