This letter supersedes our correspondence to Ewell Hopkins of March 19, 2021 regarding the Demolition of a Historic Structure on 112 Dukes County Ave.

In that correspondence, we based our determination on the fact that the subject property was in a historic district. After more consideration we have concluded that the property is in fact not in a historic district and should have been and must now be referred to the MVC.

Section 8.1 of the DRI Checklist, Version 13, is very clear.
8.1 Demolition of Historic Structures: The Demolition of any structure that:
a) has been identified as having historic significance by a local historic commission or architectural commission, by a general plan of the Town, by the Massachusetts Historical Commission, or is listed with the National or Massachusetts Registers of Historic Places (see attached map); or
b) was constructed before January 1, 1900 -with MVC Concurrence

Exempted from this section 8.1 are structures located within:

- established historic districts and which are already protected by local historical or architectural commission review that has the legal authority to condition and permanently deny an application; or
- the Martha's Vineyard Camp Meeting Association's Wesleyan Grove National Historic Landmark District

As mentioned above, properties over 100 years old or on a Massachusetts listing of historic properties must be referred to the MVC. The only exemption are those properties located in a recognized historic district.

As the property is not in a historic district it must be referred. We understand that there are other historic properties that have applied for demolition that must follow this same process.
