To whom this may concern,

The purpose of the letter is to state my objections to the proposed placement of the commercial cell towers. These towers should not be placed in a noncommercial, densely populated residential area.

Commercial development of any kind on Chappaquiddick should be investigated very carefully. The financial gain for one will be at the expense and enjoyment of many others. Sampson Ave offers some of the smallest housing lots on Chappaquiddick. There are plenty of other spaces to accommodate this tower without having a major impact on this residential area, for example, behind the community center parking lot or out by the light house.

Research indicates an overwhelming percent of homebuyers and renters are less interested in living near antennas', cell towers, or power lines. This impact could cause a loss in as much as 20% property value near these structures. We should also consider the adverse effects of living so close to the proposed towers.

At this point, it would only benefit AT&T customers unless other wireless companies come on board and with that there will be more equipment needed. This only puts a band aid on a deep wound. Ideally, there

would a long term solution that would remedy more than solely AT&T customers while leaving the aesthetics of Sampson Ave and Chappaquiddick in tact.
