As a member of the island community, I implore you to approve the permit to allow Patient Centric of Martha's Vineyard to operate a dispensary in West Tisbury. The need for a legal, professional source of this alternative medicine can not be over-stated. With the rise in opiate addiction, the need for a safer alternative is painfully obvious. As a medical cannabis patient, I can share my personal story which is an example of how cannabis can offer a partial solution to this problem. This can best be done by sharing a letter that I submitted to my surgeon after undergoing a laminectomy and fusion of 5 cervical vertebrae in 2013.

Dear Dr Groff,

In this day and age, where the prescription drug abuse crisis has reached epidemic proportions, I thought that you, and others, might find this of interest. Although I realize that this is not a broad-based study, it seems worthy of consideration.

When I was discharged from the hospital following my cervical fusion surgery, I was told that I would be on narcotics for at least 3 weeks. On the 8th day following surgery, I began weening myself off of the Oxycodone that had been prescribed, and supplementing it with Cannabis products. The products I was using were a medium-grade canna-butter (which I would spread on toast,) and inhalation of vapors from the herbal material itself. I started off using 1 TBSP of butter every 6-8 hours for the first few days, and then began taking it only before bed to relieve discomfort and aid in sleep. During the day, I would take a few puffs from the vaporizer as needed to keep me at a comfort level that was acceptable to me. Ten days after surgery, I was off the Oxycodene completely and was able to manage my pain solely through the use of Cannabis products. The benefits, and my motivation, are that it does not cause constipation, does not cause nausea, and most importantly, allowed me to stop ingesting highly addictive little pills.

As you know, the long term use of narcotics after surgery or injury all too often leads to a situation where the patient becomes dependent on the drug and ultimately becomes addicted. Due to the excessive cost of

prescription meds on the street, these people often turn to Heroin as a cheaper alternative as they struggle with their addiction. Perhaps the route I took might be something that can be recommended as an alternative for people with concern about narcotics.

The enclosed prescription for 120 Oxycodone tabs I am returning because I simply don't need them.
