1. Introduction

New Cingular Wireless PCS, LLC (“AT&T”) has applied to the Edgartown Planning Board for approval of a proposed wireless communication facility (the “Facility”) at the following site:

Owner: MV Wifi, LLC
Site: 14 Sampson Avenue, Edgartown, MA 02539
(Assessor’s Map 34, Lot 197)

This report, in conjunction with the Radio Frequency Report prepared by Dan Goulet of C Squared Systems, explains the process by which AT&T determined that this site is the location most compliant under the Town of Edgartown Zoning Bylaw to allow it to address its significant gap in coverage in Chappaquiddick. In particular, this report discusses the process and criteria by which AT&T identified and evaluated this site, and the process and criteria by which AT&T considered but rejected other potential alternatives as technically inadequate or unavailable to serve the relevant area of Chappaquiddick.

2. Qualifications and Overview

I am Site Acquisition Specialist with SAI Communications, Inc., responsible for wireless communication facility site acquisition, leasing and permitting for AT&T’s proposed expansion of its Federal Communications Commission (“FCC”) licensed network into the Chappaquiddick area off of Edgartown, MA.

I have extensive experience providing site identification, evaluation, leasing, zoning and permitting support in connection with the installation of wireless communication facilities in New England. For example, upon obtaining designated search areas (called “search rings”) from AT&T Radio Frequency (“RF”) Engineers, I use databases containing information about existing communications towers, topographical and tax maps and other tools to identify potentially appropriate wireless communication facility sites within these search rings, and provide candidate sites to AT&T’S RF engineers for evaluation. Once AT&T’s RF engineers confirm that a property is suitable for a wireless communication facility of sufficient height, I approach the property owner to determine whether the owner is interested in allowing such a facility on the owner’s property. I negotiate the terms of leases, licenses and other agreements with property owners for a variety of sites to allow AT&T to locate its facilities on the owners’ properties. I also attend and testify at zoning, planning and other hearings and meetings required for the permitting of these facilities, and I attend site visits, balloon tests and crane tests to evaluate the potential visibility of these facilities.

On behalf of AT&T, I am providing this Alternatives Analysis in connection with our application to the Edgartown Planning Board to construct and operate a wireless communication facility in Chappaquiddick (Assessor’s Map 34, Lot 197) (the “Sampson Avenue site”).

3. AT&T’s Site Search and Selection Process/Candidate Evaluations – Overview

In order to find a wireless communication facility site that will provide acceptable service and address an identified coverage gap within AT&T's network, AT&T's RF engineers use computer modeling to identify and define a search ring. The search ring is located so that a site within the ring will have a reasonable probability of providing adequate coverage to the targeted coverage area (assuming the site is available and AT&T can install its facility at a sufficient height at the site).

Once the search ring is identified, I first review the zoning ordinances of the municipality in the search ring to understand the municipality's preferences for wireless communication siting. Typically, zoning ordinances express a preference for a carrier to co-locate its new wireless communication facility on an existing tower, building or other tall structure to avoid the need to build a new tower. From AT&T's perspective, co-location is ordinarily the most efficient and cost-effective way to site and install a new facility because it avoids the need to design, obtain approvals for and construct a new tower and access drive, thereby saving significant time and capital costs. Co-location also enjoys certain regulatory preferences at the federal level, such as streamlined (i) permitting, (ii) historic preservation approval under existing Programmatic Agreements and (iii) consideration of Federal Aviation Administration ("FAA") marking and lighting requirements because the existing support structure already exists.

As a result, it is my standard practice to begin my search within the defined area for any existing tall structures – such as existing wireless communication towers, water tanks, electric utility stanchions and tall buildings – where AT&T could co-locate its antennas and equipment as an alternate to constructing a new tower. Specifically, I look for existing structures that are of a substantial height and suitably located that co-location will likely enable AT&T to address its identified coverage needs by providing the necessary quality and extent of coverage to address the targeted coverage area. I use various public and private information sources – including both generally available and proprietary communication facility tower databases (such as the FCC's Antenna Structure Registration database and the Crown Castle International CCIsites™ tower location database), topographical maps and municipal assessor and tax maps – to identify potentially appropriate wireless communication facility sites within a search ring. I also travel the search ring area by car and, where necessary, on foot to identify existing buildings and other existing structures of sufficient height. Where I am unable to locate an existing building or structure of sufficient height and in a suitable location within the search ring, I examine the area for a suitable property at which AT&T could propose a new tower consistent with local zoning requirements. I also work to determine if the Town is interested in using Town-owned property for a site or if their bylaw requires the use of Town-owned property.

Once I identify a potential site to address AT&T's identified wireless network coverage gap, I present the candidate site to AT&T's RF engineering group, which evaluates whether a facility at the proposed location can generate sufficient signal strength to provide suitable in-building and in-vehicle wireless coverage in the targeted coverage area. AT&T's RF engineer assigned to the area determines this by preparing RF coverage maps using an RF propagation computer modeling program that takes into account such factors as the geographical features of an area, the location and height of the proposed AT&T facility, the antenna model(s), and RF transmitting power. Taking into account AT&T's other existing and proposed wireless facility locations in

the area, the resulting coverage plots depict which portions of the targeted coverage area would have suitable coverage with the proposed facility and which will not.

If AT&T's RF engineers approve a potential candidate site, I then attempt to negotiate a lease or other appropriate agreement with the owner of the property or the existing tower or structure in question. If these negotiations are successful, AT&T begins its title and environmental due diligence process, the facility design process, and the permitting process.

4. AT&T's Site Search and Selection Process/Candidate Evaluations

AT&T holds multiple FCC licenses to provide digital wireless communication services within this area of Edgartown including Chappaquiddick. Due to the nature of wireless communications facilities such as AT&T's, facilities are generally required to be located in relatively close proximity and at relatively high elevations (compared to the surrounding topography) in order to ensure that a user moving between sites is able to remain connected to AT&T's network.

Currently AT&T has significant coverage gaps throughout the Chappaquiddick area. As a result, AT&T is in the process of expanding its network to fill in the gaps in Edgartown and Chappaquiddick. As part of this process, AT&T's RF engineering group has identified significant coverage gap including just about all of Chappaquiddick (collectively, the "Targeted Coverage Area"). AT&T is seeking to site a proposed wireless communication facility in Chappaquiddick to address these gaps and connect with coverage from AT&T's planned and existing facilities in town and in abutting towns.

Site Search History & Candidates Evaluated

AT&T has had a search ring for a permanent site on Chappaquiddick since 2011. Due to changes in network priorities since the search ring was first released, the search ring's status has changed from active to "on-hold" off and on. The original search effort was coordinated closely with Town officials and their consultant David Maxson. The initial search involved evaluating Town-owned properties for potential sites.

The original 2011 site selection process resulted in a focus on a Town-owned parcel on Litchfield Road (Assessor's Map 35, Lot 11). However, the Town ultimately released an RFP (Request for Proposals) for a Neutral Host Distributed Antenna System on February 12, 2012. In approximately, May of 2012, the RFP was awarded to named Grain Communications, a tower and distributed antennas system ("DAS") developer. At some point thereafter, AT&T's search ring was put on hold.

However, AT&T continued to monitor the development of a DAS system for Chappaquiddick. In 2013, AT&T received a copy of a letter from the Edgartown Board of Selectmen addressed to State Representative Timothy R. Madden requesting his help in encouraging all FCC licensed carriers to commit to using the proposed DAS network. However, AT&T determined that a single-site solution, sometimes referred to as a "macro solution," was more appropriate for its network needs instead of the proposed DAS.

In August of 2015, AT&T was contacted by Adam Darack, IT Manager for the Town of Edgartown seeking carrier input for potential coverage solutions for the Cell Committee. As a result of that initial conversation, AT&T representatives attended a Cell Committee meeting via telephone on August 13, 2015. AT&T Radio Access Network (RAN) engineers explained AT&T's preference to use a tower as a macro solution to provide coverage to Chappaquiddick instead of the proposed DAS solution. During that meeting, AT&T was also asked about various aspects of its funding process and interest in providing coverage to Chappaquiddick. One of the questions posed to AT&T was whether there were any potential temporary measures that might be available, for example COWs (a Cell-Site-On-Wheels) or temporary poles or towers. AT&T also learned of the Town's desire to provide critical coverage to the beach areas during the summer. Such coverage would be beneficial for public safety needs and any emergencies happening on the crowded beaches.

Following AT&T's call with the Cell Committee in August of 2015, AT&T's RAN Director started a process to seek funding for a temporary COW site. AT&T also worked with the Cell Committee to identify potential properties for the temporary site to address the immediate need on Chappaquiddick, during the additional time necessary to identify, permit and construct a permanent site to address AT&T's Targeted Coverage Area . As a result of AT&T's efforts, in cooperation with members of the Cell Committee, the property at 14 Sampson Avenue was identified as a potential location for the temporary facility.

AT&T evaluated six candidates in connection with its efforts to locate a feasible location for the temporary facility. In addition, each of these candidates was further considered for the location of the proposed permanent facility. However, AT&T has determined that, with the exception of the Sampson Avenue Property, each of the remaining five locations considered for a temporary location is not reasonably feasible for a permanent facility, as follows:

1. **67 Dike Bridge Road** – The property is owned by the Town of Edgartown. The property has not been made available for lease through a Request for Proposals.
2. **28 Forest Avenue** – The property is owned by the Town of Edgartown. The property has not been made available for lease through a Request for Proposals.
3. **29 Old Indian Trail** – The property is owned by the Town of Edgartown. The property has not been made available for lease through a Request for Proposals.
4. **Bay View Avenue** – The property is owned by the Town of Edgartown. The property has not been made available for lease through a Request for Proposals.
4. **23 Pocha Road Extension** – The property is owned by the Trustees of the Reservation. Although the property was under consideration as a potential location for the temporary facility, the property is not available for lease for the permanent proposed facility.

Upon receiving approval of the subject site for a temporary PWSF, AT&T began the process of searching for the most appropriate property at which to locate a permanent facility.

As a result of AT&T's prior efforts to locate a permanent facility and the temporary facility on Chappaquiddick, I was already aware that there are no existing structures, including the existing MV WiFi tower, upon which AT&T can co-locate a facility to provide adequate coverage to the Targeted Coverage Area. Therefore, I reviewed the Town of Edgartown Zoning Bylaw ("Bylaw") to determine the criteria applicable to AT&T's proposed permanent facility. In order to comply with Article XXIII, Section 23.5(c) of the Bylaw, I performed a thorough and complete evaluation of potential candidates, there were not previously identified or evaluated, at which AT&T could potentially locate a permanent wireless communications facility. My analysis of potential locations for a permanent facility included:

- Determining that the Chappaquiddick Island area of Edgartown is located entirely within the R-120 Zoning District. Pursuant Section 3.1 of the Bylaw, the R-120 Zoning District requires a minimum lot size of three (3) acres.
- Cataloging and reviewing all parcels within the search ring, regardless of size . This evaluation identified 397 potential parcels located in and near AT&T's identified search ring.
- Expanding the scope of the area reviewed, because some of the parcels on the outermost edge of the ring were found to be acceptable from a RF standpoint. As a result, the search ring was expanded, and an additional 26 parcels were examined in an attempt to determine the outer limit of viability.
- Examining a total of 425 alternate candidates,¹ 85 of which were eliminated as either unacceptable to RF or held in one of several conservation trusts and therefore determined to be unavailable.
- This number was further reduced by applying a minimum size limit of 3 acres, which is the minimum lot size currently allowed in the R-120 zone (eliminating the need to request a dimensional waiver from the Planning Board), yielding 56 potential candidates, three of which had common owners.

A proposal to lease ground space for a PWSF was then extended to all of the potential candidates. Certified letters were sent to 52 of the unique property owners identified and one was contacted by telephone. Forty-seven green return receipt cards were received. Three other cards were returned as undeliverable. Of the 53 offers extended, 21 responses were received by fax, e-mail and telephone, 14 as not interested and 7 as interested. The owners of the other 32 properties did not respond.

A draft Option and Lease Agreement was then sent to the seven interested respondents. After consideration, four rejected the proposal and three opted to negotiate terms. Upon further investigation, it was determined that one of the three remaining candidate parcels (30 Ambers Way) is landlocked, and there is no reasonable expectation of being able to gain access. As a result, this property is not a feasible alternative

The other two remaining properties, 2 Majane Lane, and 14 Jeremiah Road, have now been leased by AT&T. After reviewing all three locations (including the subject property), AT&T determined that the subject property is the most feasible alternative that is most compliant with the Bylaw overall.

Therefore, as of the date of this Report, AT&T has thoroughly evaluated the relevant geographic area and the specific properties identified above as potential alternative locations for a wireless communication facility to address the Targeted Coverage Area on Chappaquiddick. AT&T has evaluated these properties in an effort to identify a suitable location for its proposed facility and determined that the subject property remains the best and most Bylaw compliant alternative from which it can address this significant gap in its wireless network coverage in the desired timeframe.

The proposed permanent facility will be a 115' multi-carrier monopole capable of supporting AT&T, MV WiFi, LLC, plus at least two other commercial wireless carriers. It will replace both the existing 84' guyed tower and AT&T's temporary monopole. By replacing the existing tower on the property with a permanent Facility that will accommodate AT&T's radio communications equipment, as well as the MV WiFi equipment, the proposed Facility minimizes the number of new towers within Edgartown. Any other location that could provide adequate coverage to the Targeted Coverage Area would require the introduction of a new tower to a property and area that is not already used for wireless communications purposes. Therefore, by minimizing the number of new towers, eliminating the existing guyed-tower, locating the Facility on a property already used for wireless communications, and in a location that minimizes visibility of the Facility from Edgartown and Chappaquiddick as a whole, the proposed Facility at the property most fully complies with the objectives of Article XXIII of the Bylaw.

5. Summary

AT&T has completed a thorough evaluation of Chappaquiddick area concerning the availability and feasibility of potential alternative locations for a wireless communication facility to address the Targeted Coverage Area. For the foregoing reasons, including my review of the Bylaw, my personal knowledge of the area, the location of AT&T's existing and proposed facilities, and analysis provided by AT&T's radio frequency expert, neither of the two alternative candidates identified are superior to the proposed Facility at the Sampson Avenue site because choosing any other site would mean adding an additional tower to Chappaquiddick. The Bylaw is clear in its preference for minimizing the number of towers in town. The Sampson Avenue site is unique in that it provides adequate coverage to the target area with one tower and therefore, in my professional opinion, is the least intrusive and available alternative to provide adequate coverage to this significant gap in AT&T's wireless network coverage. Accordingly, the proposal currently before the Board provides the best alternative for AT&T to provide adequate coverage to its significant gap in reliable network coverage.
