



RE: Downtown Target Area Slum & Blight Designation

Dear Mr. Vail:

The Massachusetts Community Development Block Grant (CDBG) Program received the Town of Oak Bluff's request for approval of the above named target area, allowing the Town to carry out projects in the area using the national objective of prevention or elimination of slums or blight on an area basis. The submittal included a description and map of the target area, a determination that the area meets the criteria set forth in M.G.L. 121A and 121B, and an inventory of conditions in the target area. Based on the material submitted, the target area and supporting inventory have been accepted for national objective purposes, and are valid for a ten-year period beginning July 1, 2014 and ending June 30, 2024.

This does not in any way qualify any <u>activity</u> or <u>project</u> proposed in the target area as meeting the national objective or other threshold criteria. Each activity proposed in a Massachusetts CDBG application must also meet the program criteria in effect at the time of application to be eligible for funding consideration.

If the Town is to apply for an activity or project in the target area prior to the expiration of the ten year period noted above, and is seeking to qualify the activity or project under the national objective of prevention or elimination of slums or blight on an area basis, a copy of this letter should be included in place of the inventory and other supporting materials. DHCD will then confirm consistency of those proposals with the approved target area.
