1. Project – DRI 345-M5 Island Cove Apartments – Approval of Traffic Scope

Applicant: 386 State Road, LLC; BarKay 386 LLC; Brook Katzen
Proposal: 40B Comprehensive Permit for a mixed-use building with 54 residential units and 2,000 ft² of commercial space, and 53 parking spaces.
Location: 386 State Road, Vineyard Haven. Map 22-A, Lot 13.1 (approx. 0.8632 acres)
Purpose: To review the proposed traffic scope and determine if it is complete and ready to be submitted to the engineers for a full traffic study.
