Hi Alex -

We know that you, staff and committee members are very busy

We thought it would be helpful to summarize the 3 primary reasons we are seeking demolition - in order to use your time as efficiently as possible tomorrow

We are seeking demolition for 3 reasons:

First, significant alterations were made to the house in 1948 by my father-in-law (the old picture in the file may be of some help) - victorian porch removed, living room and master bedroom added, all new walls and floors, 2 new dormers

Second, is the cost and practicality of repairing the old house - due to rot, lead and code most of the house needs to be rebuilt at an estimated cost of \$1m+ - and when done we have a replica of an altered Greek revival - not the original

Third, the house has no historical significance and is not visible

Phil and Sean will speak to the proposed new structure
