Thank you for your reply.

Your latest application submission states, "We have spoken with representatives of Greenfields USA, who have just opened a turf recycling facility in the Netherlands and are committed to opening another facility in the United States within the next 2 years."

According to their last press release from March 26, 2020, the Dutch facility had not yet opened. Further, there was no announcement on social media regarding it becoming operational — and nothing about a planned expansion to the US. The <u>GreenFields USA</u> website does not appear active at this time. So we are a bit confused.

After publicly referencing the (nonexistent) Pennsylvania ReMatch facility, we had hoped that in this round and at this stage in the process, Huntress Associates would have verification and information in hand for the MVC and Oak Bluffs Planning Board to assess this new recycling facility.

We understand that much of the due diligence for proposed projects is done in advance of the public hearing, so we are cc-ing the MVC and OBPB so they can follow up.
