Dear MVC Commissioners and Staff Members,

My name is Bryan Nelson, I am the owner of A-A Island Auto Rentals located at 31 Circuit Ave Extension on the property of Anne deBettencourt, at the North Bluff. Collectively, Anne deBettencourt and I have been renting, Jeeps, Bikes and other items from that location for over 45 years.

I am writing to voice my concerns on the recent proposed changes regarding the two tour bus parking spots on DRI 659-M.

The new proposed parking spots for two busses directly in front of my rental Jeep staging area will have a drastic negative impact on our ability to rent Jeeps, move them freely on and off the street, and will create numerous safety concerns for renters and tour bus passengers alike. The second of the two newly proposed spots, are right in the middle of our active parking area. I strongly disagree with the proposed spots.

I think a fair alternative and a more sensible spot would be the first two parking spots at the foot of the wooden boardwalk (next to the #9 on the plan) to the immediate left of the handicap parking spot. This will allow for an easy departure up Seaview Ave Extension, and reduce congestion on Circuit Ave Extension.

For the record, I have not been contacted by anyone from the town or otherwise regarding this project, which is disappointing to say the least. I have been standing out

on Circuit Ave Extension every day from May to October, 7 days a week for over 18 years.

Some other concerns I see, are the following:

If someone stops in the circle to pick up or drop off friends and family, gridlock will occur. No room for error.

Room for one large truck to load and turn at Patriot Boat is not feasible. I was down there last week at 11 AM, on Thursday, and there were 5 or 6 trucks loading and unloading, and we are not even in season.
