## Modification of Previous Decision SUMMARY

The Martha's Vineyard Commission (the Commission) hereby modifies the Decision of the Martha's Vineyard Commission dated July 10, 1997 and recorded in the County of Dukes County Registry of Deeds, Book 704, Pages 237 through 242 regarding the Application of Options in Education, Inc., PO Box 860, West Tisbury, MA 02575 for the construction and operation of a public charter school.

The Martha's Vineyard Commission held a Regular Meeting on Thursday, June 25, 1998 at 8:00 p.m. in the Commission Offices, Olde Stone Building, New York Avenue, Oak Bluffs, MA.

Under Item #7 Old Business, Thomas Simmons, MVC Administrator explained the request from the Charter School which was to be permitted to increase the total number of persons (students and others combined) from 120 to 140 persons.

Following discussion, Ms. Greene moved, duly seconded, that the change being proposed to the DRI Decision, in accordance with the Regulations of the Martha's Vineyard Commission, Section 2.500(5)(b) Modification of a Previous DRI Decision, was an insubstantial change due to the fact that the septic system was now a Title V system and not an alternative as originally proposed. It was then moved by Ms. Greene, duly seconded, that the Commission should approve of the modification as requested by the Charter School. The motion was approved in

the affirmative.

The Decision of the Martha's Vineyard Commission, dated July 10, 1997 and duly recorded in the County of Dukes County Registry of Deeds, Book 704, Pages 237 through 242 is hereby modified as follows:

The phrase, "one hundred twenty (120) persons" is hereby deleted from Condition 1a and in place thereof is substituted the phrase, "one hundred forty (140) persons".

Any and all permit granting boards or officers having jurisdiction may now proceed in accordance with applicable local and state laws to approve, approve with conditions or deny the Application request of Options in Education - Martha's Vineyard Charter School.
